MEMORANDUM FOR: COWG MEMBERS

SUBJECT: COWG COVID Remobilization

1. Effective 7 January 2022, Colorado Wing will transition to Phase 1 of the national COVID-19 remobilization plan. The decision to move to Phase 1 was directed by NHQ based on the positive COVID cases reporting on the www.covidactnow.org website.

2. Phase 1 restricts weekly in-person meetings or activities of cohorts of 10 members or less. Per NHQ, up to 25 vaccinated members, meeting outdoors, and socially distanced are allowed in Phase 1. [NHQ Vaccination Memo 1 Jun 2021](#).

3. School squadrons may operate in accordance with the school district's guidance for COVID-19 gatherings.

4. Masks. Per NHQ, all members, whether vaccinated or unvaccinated, are required to wear a good quality, well-fitted facial mask when indoors during periods of high infection rates. COWG will define High Infection Rates as Phase 1 remobilization.

Aircrew and ground teams are encouraged to wear face coverings as additional risk mitigation when flying with non-CAP passengers or non-vaccinated members. The CDC is strongly recommending masks in any enclosed situation for both vaccinated and unvaccinated individuals.

5. Vaccination Requirements. While CAP does not currently require any vaccinations, vaccination for COVID-19 is strongly encouraged for all members, both cadets, and seniors.

6. Social Distancing in Vehicles. When transporting members, everyone in the vehicle must wear a good quality, well-fitting facial covering in Phase 1. Arrange seating to maximize the physical distancing. If all members are vaccinated, seating can be adjusted up to the vehicle maximum. Ensure that cabin vents are open and allow for airflow into and out of the van. If you are driving without passengers, a mask is not required.

7. In the event of any additional restrictions are set forth by the state or local county health ordinances, the most restrictive orders shall supersede those listed here.

8. Moving back to Phase 1 is not the way any of us wanted to start 2022. Please stay vigilant in following these guidelines. It is important through these challenging times that we stay connected and engaged in online meetings, training, and activities. COWG is in the process of reworking our Phase 1 remobilization plan that is published on NHQ's remobilization website. Thank you for your patience and understanding as we continue to work through that process.

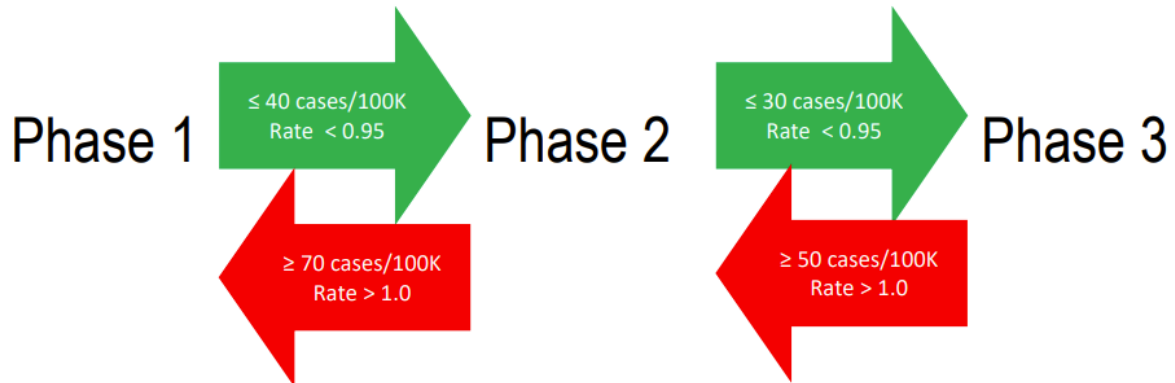
